Deposits: A non-refundable deposit is required with each enrollment form. This deposit will be applied to your trip account once your trip is completed. For London & Paris, the deposit is \$500 **per person**. For Jamaica, the deposit is \$250 **per couple**.

Bonus Trip Reward: CDC Distributors will award bonus points as follows:

- **1%** of your total sales volume will be awarded as Bonus Points.
- **2%** of your total sales volume if that amount matches or exceeds last year's sales volume.
